



I served in the USAF as a veterinarian for 3 years, was in Private Practiced for 19 years, worked for Pfizer Animal Health (now Zoetis for 10 years, and am currently working on the Navajo Nation at the Monument Valley Agri-Science Center/ N.A.T.I.V.E. 2 ¾ years. I can certainly say without hesitation that I could not prepare or do an acceptable job of teaching without the iCEV Veterinary Science program. The program is very comprehensive and has been developed with a great deal of planning and thought. The course contains 40 separate modules, providing a variety of teaching methods, not limited to videos and power point presentations. The program covers a wide spectrum of subjects, including veterinary terms and terminology, animal behavior, animal welfare, anatomy and physiology, interviews with veterinarians regarding specific job descriptions, and many, many more subjects.

There was a Veterinary Science project in 4-H that I taught for several years while living in Kansas. It didn't touch the surface of material when compared with this curriculum.

We receive feedback from Veterinary Technician teaching institutions stating how advanced our students are in comparison to those who haven't taken the course.

I grew up in the San Luis Valley, blessed with the opportunity to be surrounded by animal agriculture. With that, I gained pivotal exposure to the field of veterinary medicine. I was able to see firsthand the importance of timely veterinary care and the critical role that veterinarians play in society. Because of this, and my passion for production agriculture and science, I decided to pursue a career in veterinary medicine. I am currently a second-year veterinary student at Colorado State University. In addition to my role as a veterinary student, I serve as the Vice President of CSU's Student Chapter of the American Association of Bovine Practitioners and am a student small animal radiology technician at the Colorado State Veterinary Teaching Hospital.

Coming from a rural area, I had the unique opportunity to engage in veterinary related activities at a very young age. However, I didn't realize the broad scope of the veterinary profession until well into my first year as a veterinary student. The opportunities for veterinary careers extend so far beyond clinical practice, a fact that remains unbeknown to most. Additionally, my rural perspective provided limited experience in the options and incredible advancements in clinical veterinary medicine itself. The terms "veterinary medicine" and "veterinarian" can have a far more diverse meaning than I ever would have imagined.

A certification program that provides access to more a well-rounded view of the entire scope of the veterinary career field, as well as instruction in the technical skills involved veterinary medicine would have better equipped me for my journey into vet med. As I began my college career, I found myself feeling daunted by the myriad of input from innumerable sources all telling me what I "should" do if I wanted to become a veterinarian. Because of this, I turned to what I knew and sought out rural veterinary instruction. Had I have known just a little more about the various facets of the field, such as research, specialized medicine, and translational medicine, my vet school application certainly would have been much stronger and far more diverse.

I am confident that had I been able to earn the Elanco Veterinary Medical Applications Certification in high school, I would have been more prepared to begin the rigorous journey towards my DVM degree. This program would have helped me solidify earlier on that I was truly passionate about veterinary

medicine so that I could have been more calculated in my approach to vet school admission throughout undergrad. It would have also given me confidence in my fundamental skillset as I approached potential mentors and veterinarians whom I hoped to shadow and observe.

Having a strong background in veterinary medicine concepts is vital in the decision to pursue any level of degree in veterinary medicine. At the most basic level, understanding what the role of a veterinarian is in the clinical process of veterinary care isn't as clear as it seems. So many of my undergraduate peers chose their undergraduate university and major with their eyes set on becoming a veterinarian only to realize that they actually didn't enjoy veterinary medicine at all. Others spent exorbitant amounts of money on university tuition to find that they would actually want to be veterinary technicians and then had to enroll in a technical school to earn that degree. The chance for these students to have gained a deeper understanding of veterinary concepts in high school would have saved them time and money. No less important is that the veterinary school application requires a detailed list of all veterinary experience. While each school weights their emphasis on this portion of the application, all unanimously agree that veterinary experience is critical to success as a veterinary student and eventually as a veterinarian. The more avenues available to help students gain that critical experience, the better.

As I conclude this my letter of support for the Elanco Veterinary Medical Applications Certification, I must reiterate the how important it is that students have the opportunity to develop a solid background in the concepts of veterinary medicine before they begin their pursuit of a veterinary career. Just a few of the reasons that this type of education is so critical are that there is far more the career field of veterinary medicine than most realize, a veterinary degree is not the only avenue for involvement in clinical involvement in veterinary medicine, personal experience in the field has a huge impact on the perceived opportunities, and increased exposure and experience in the field always helps strengthen veterinary school applications. I am writing this letter in support of the Elanco Veterinary Medical Applications Certification.

My name is Mallory Kahler and I have been a mixed animal veterinarian for 6 years. I am currently employed at Lincoln Way Animal Hospital in Upper Sandusky Ohio, with two satellite clinics in Sycamore and Bucyrus Ohio. We employ 4 full time veterinarians, 4 registered veterinary technicians, 1 receptionist, and 1 assistant. I have worked in this position for the past 3 years and in the that time we have struggled to find qualified employees when hiring support staff for our clinics. Even when hired, our entry level positions have a high turnover rate.

Individuals who earn this certification have demonstrated possession of knowledge and skills vital to succeeding in animal health care careers. When we hire a new staff member for our entry level positions (vet assistant, receptionist, kennel staff) veterinary terminology can almost be a language barrier. This creates a disconnect with clients as well as amongst team members. This initial communication issue can reflect poorly on the clinic and it can also lead to miscommunication and frustration amongst the clinic staff. Having this certification and training will help them communicate with clients more effectively, and understand veterinarians and staff on day one, leading to better teamwork among our staff, better client satisfaction, and decrease turn over in our entry level positions. On the job training is still a must, but candidates with this certification will be more career ready.

This certification is what the veterinary industry needs because it's a practical and obtainable skill that we can measure for those candidates without advanced education (technician or veterinary degree). This demonstrates both a drive and commitment from the student in the field, as well as assures a basic knowledge base. Our industry needs more qualified candidates like that for entry level positions.
