CERTIFICATION OVERVIEW

The National Horse Judging Team Coaches' Association (NHJTCA) Equine Management & Evaluation Certification verifies individuals are prepared to pursue a career in the fields of equine evaluation, management and production. The certification exam assesses knowledge of the equine industry, including equine anatomy and physiology, equine diseases and breed identification.

EXAM OVERVIEW

The NHJTCA Equine Management & Evaluation Certification is hosted on the iCEV testing platform. The certification exam is a 100-question, randomized assessment. Exam questions are in the format of multiple choice, sort order, diagramming, matching, labeling and other question types meant to fully evaluate an individual's competency of the industry standards. The certification exam should be proctored within a controlled environment. The proctor of the exam must review and verify all exam procedures and provide electronic documentation through the exam platform.

Optional Preparation Materials Overview

The preparation materials offered by iCEV for the NHJTCA Equine Management & Evaluation Certification was specifically created to prepare candidates for the certification exam. While it is not required to complete the preparatory materials before accessing the certification exam, NHJTCA recommends certification candidates complete some form of training. The following outlines the lessons scope and objectives:

Lesson 1: The Equine Industry

- 1. To demonstrate competencies related to resources, information, interpersonal skills, and systems of operation in equine science.
- 2. To demonstrate knowledge of personal and occupational health and safety practices in the workplace.
- 3. To recognize the importance of the equine industry such as rodeo, racing, equestrian, therapy and the global food market.
- 4. To evaluate and select horses based on purpose.
- 5. To identify procedures for breeding horses per industry standards.
- 6. To describe issues concerning biotechnology related to the equine industry.
- 7. To identify welfare policy pertaining to the equine industry such as rodeo, racing, equestrian, therapy, global food market and pharmaceutical research.

- 4. To gain skills on coaching and judging halter.

Lesson 10: Horse Evaluation: Western Pleasure

- 1. To understand the rules and standards which are important for judging the western pleasure class.
- 2. To recognize the faults and disqualifications which affect the placing of the western pleasure class.

Lesson 11: Horse Evaluation: Western Horsemanship

- 1. To understand the rules and standards which are considered important criteria for judging the Western Horsemanship class.
- 2. To recognize the three (3) point, five (5) point and ten (10) point penalties and disqualifications which affect the placing of the Western Horsemanship class.
